



## 2017 KidStrong Conference / Immunization Summit Online Evaluation

Please review these instructions to complete the 2017 KidStrong Conference / Immunization Summit Online Evaluation and to receive your Continuing Education Certificate or Certificate of Attendance.

### Online Conference Evaluation

**There are two ways to complete the evaluations and apply for Education Credits or Certificate of Attendance.**

- 1) On the first day of the conference, most attendees will receive an *email invitation* with instructions on how to proceed with the online evaluation and application for education credit. Using this *personal email link* you may re-enter the online program as often as desired until the Submit Evaluation button is clicked. Additional directions are provided in the email.
- 2) For those who did not receive a personal email link, you will have the opportunity to provide feedback and apply for education credits by clicking on this link *after the Conference is over at 5:00 pm on Thursday, June 22, 2017* [https://www.surveymonkey.com/r/CEU\\_2017KidStrong](https://www.surveymonkey.com/r/CEU_2017KidStrong) This link requires that your evaluations and CEU application *be completed and submitted once started*. Clicking on the link again will only start the survey from the beginning. Additional directions are provided within the survey to guide you through the process.

### Continuing Education or Certificate of Attendance

Physician CMEs and Pharmacy Education credits will be made available by the WV Immunization Network for all sessions in the Immunization Summit track. Physicians and pharmacists can receive CMEs/CEUs by signing in at the Immunization Summit registration desk at the start of the conference and are commensurate with the extent of your participation and completion of the evaluations.

Nursing, Social Work, Speech-Pathology & Audiology, Counseling Continuing Education Credits and Certificate of Attendance (for teachers, administrators and other school personnel) are available online after completing the online conference evaluation and CEU application.

You will have until **July 21<sup>st</sup> 2017** to complete the evaluations and print your certificate.
