Overall Approach for Reimagining Instructional Time/Instructional Day

Ohio County Schools overall approach for reimagining instructional time/instructional day is first to utilize the current Continuing Professional Development Day (CE), Outside School Environment Days (OS), Out-of-Calendar Day and the Preparation for Closing School Day (P) in the 2015-2016 school calendar to make up closed instructional days due to inclement weather conditions. Ohio County Schools has nine days that can be converted into instructional make up days. The chart below defines the possible nine make up instructional days. (See Appendix Item A – Ohio County Schools 2015-2016 School Calendar)

Ohio County Schools proposes to utilize “Summer Savers” containing appropriate programmatic level and grade level content to provide up to five days instructional time to replace attendance time for all Ohio County students for inclement weather closures only for Day 10, Day 11, Day 12, Day 13, and Day 14. The “Summer Savers” will incorporate the same amount of instructional time as regular attendance time.

The Reimagined Instructional Time/Instructional Day will occur in a learning environment outside of the school. The learning environment may be our students’ homes, the Ohio County Public Library, or the YMCA.

*Ohio County Schools reserves the right to change any of the “Summer Savers” to closed days to be made up in June, 2016, if the weather conditions are justified. Weather conditions justifying school closures may include a state of emergency with travel limitations. The “Summer Savers” will then be moved to days in June, 2016.

Ohio County's reimagined school day allows students to work at home on appropriate grade level content on Day 10, Day 11, Day 12, Day 13, and Day 14 on "Summer Savers" in lieu of make-up instructional time in their classrooms. The "Summer Savers" will give special consideration to elementary/early learners who are not independent learners by focusing upon reinforcement and integration of skills provided during regular instructional days. Middle and high schools students will be provided with reinforcement and integration of content learning activities as well as application of skills in all core content areas. "Summer Savers" include all content areas. "Summer Savers" will be available on the district Edline and individual school Edline sites, and students who do not have Internet access at home will receive their "Summer Savers" in paper format.

Students are to submit completed "Summer Savers" work as soon as possible, up to ten days from the date they return to school to allow for technology issues, family emergencies, or illnesses. "Summer Savers" assignments will take the place of work that would have been completed in school. Students will receive a grade for each assignment in the "Summer Savers" from the classroom teacher.

"Summer Savers" will reinforce the academic content the students are learning in school when school is not in session. In other words, Ohio County students will be completing their school work in another location if Ohio County Schools exceeds the nine scheduled make up instructional days.

Ohio County Schools secured stakeholder support through the following processes:

- Ohio County Board of Education discussed and shared ideas about the Reimagining Instructional Time/Instructional Day application
- Educators agreed to work an eight hour work day

Evidence of Capacity and Previous Experiences with Non-Traditional Environments

Ohio County Schools has traditionally prepared “snow day” packets titled “Maximizing Instructional Time” at each school to support extended learning opportunities and reinforcement of essential skills.

Ohio County parents have always supported the completing of “snow day packets” and reinforcement of extended learning opportunities for students.

Traditionally, Ohio County Schools has utilized all Outside School Environment days, Continuing Professional Development days, and Preparation for Closing day in the school calendar as make up instructional days to compensate for inclement weather closed days. We will continue to use these days as make up days and utilize the “Maximizing Instructional Time” “snow day” packets.

Learning Management System

- **Development of appropriate content for “Summer Savers”**
 - Each school will develop appropriate “Summer Savers” to account for a minimum of 5 hours of instruction per day up to five days for Reimagined Instructional Time. Teachers will develop “Summer Savers” in all content areas.
 - The “Summer Savers” will give special consideration to elementary/early learners who are not independent learners by focusing upon reinforcement and integration of skills provided during regular instructional days. Middle and high schools students will be provided with reinforcement and integration of skills provided during regular instructional days. Teachers will include sufficient instructional work to correspond to five hours of instruction per day.
 - Teachers will receive professional development on how to prepare independent learning activities that include the integration of technology.
- **Monitoring of completed work**
 - Each teacher is responsible for monitoring completion and grading the “Summer Savers.” The teacher will assign a grade to each “Summer Saver” which will be included in the grading period. Students are to submit completed “Summer Savers” work as soon as possible, up to ten days from the date they return to school to allow for technology issues, family emergencies, or illnesses.
- **Incorporation as “instructional time”**
 - “Summer Savers” will be available on the individual school Edline pages, and students who do not have Internet access at home will receive their “Summer Savers” in paper format. Students will engage in learning activities which include reading, writing, research, applications, and reasoning.

Professional Learning for Certified Staff

All Ohio County Schools Central Office Administrators and Principals were trained by RESA-6 Regional School Support Specialist Cheryl Tuba on “50 in 50+” technology integration learning activities on October 15, 2015.

School principals will provide professional learning and model the “50 in 50+” technology learning activities to their faculty. The technology activities are aligned with Ohio County Schools Policy 3027: *Educational Purpose and Acceptable Use of Electronic Resources, Technologies and the Internet*.

All Ohio County Schools currently have collaborative learning teams in place which focus upon the following key practices:

- What do students need to know and be able to do?
- How will we know if students have learned the content?
- What do we do if students haven’t learned the content?
- What will we do if students already know the content?

Ohio County professional educators have been fully engaged in professional learning communities, and this process has long been embedded into professional practices aligned to school improvement efforts. Annually, all schools analyze their student learning and achievement data, develop SMART goals, identify and implement strategies which will maximize student learning and achievement, and monitor and adjust their instructional practices to improve and support personalized learning for each and every student in their schools. All schools identify the lowest 25% of their students who are academically at risk and then identify intervention strategies which are personalized to meet the needs of those students, whether they are academic, behavioral, or motivational interventions which will help assure student success.

All Ohio County Schools engage in professional development which focuses upon “action research” projects tied to research-based instructional improvement and funded by Title II annually. Examples include the following action research projects: Jensen’s *Engaging Students with Poverty in Mind* and *Making Thinking Visible* by Ritchhart, Church, and Morrison. In 2015-2016 many elementary schools are implementing Boushey and Moser’s *The Daily Five* which focuses on a framework for structuring literacy time so students develop lifelong habits of reading, writing, and working independently.

Other 2015-2016 action research studies in Ohio County Schools include: *The Café Book* by Boushey and Moser and *Becoming a Learning School* by Killion and Roy.

Middle Creek Elementary School is also participating as a Catalyst Learning School during 2015-2016, and all Ohio County principals will receive professional development during 2015-2016 about the “Learning School” model and its focus on the importance of professional learning for teachers in order to improve their instructional practices to achieve improved student learning and achievement results.

Strong collaboration exists with RESA 6, and professional development is supported through the Principals Regional Institutes twice a year as well as collaborative professional development with multiple schools in Ohio County.

Wheeling Park High School currently utilizes Edline online learning modules for completion of coursework as well as online courses. Some Wheeling Park High School teachers currently implement a “flipped” classroom approach to deliver instruction through Edline. Nearly all high school students access Edline through their phones. Individual teachers will post “Summer Savers” course work for each day, and the principals will monitor that work is posted and available to assure instruction and student learning are occurring.

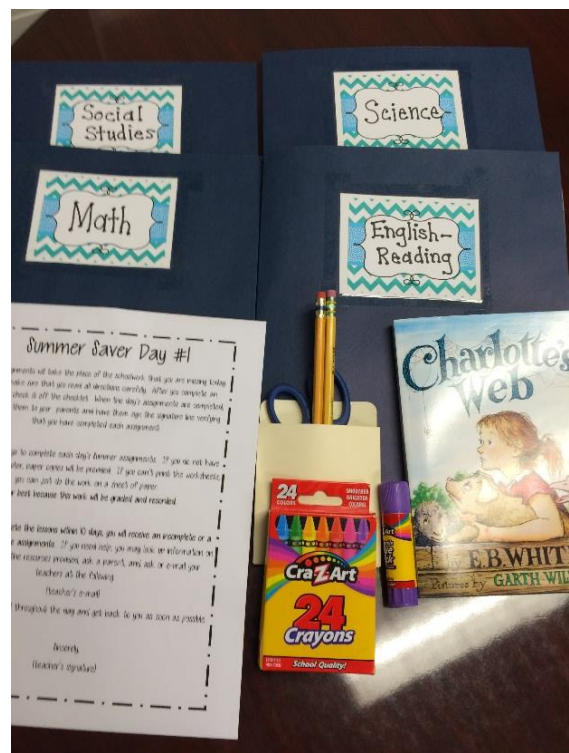
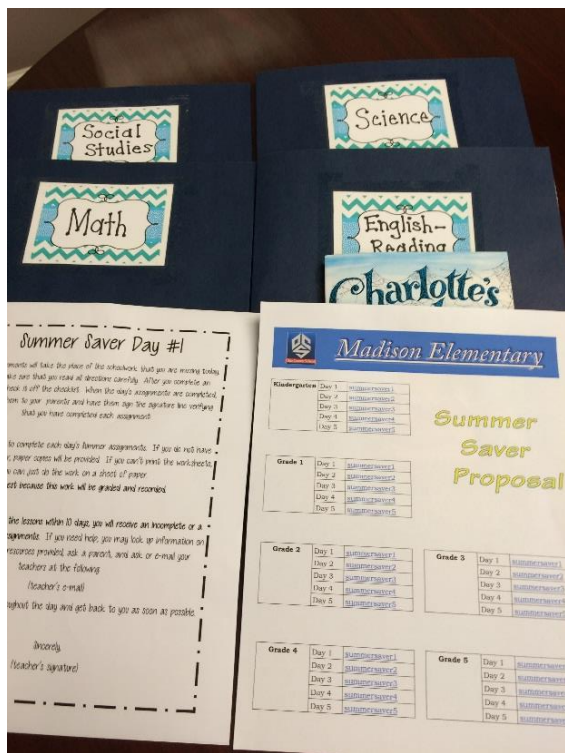
Exemplars of “Summer Savers” are provided at the elementary, middle, and high school programmatic levels.

Elementary Schools Exemplars

At the elementary programmatic level, Ohio County teachers who prepared the Exemplar Summer Saver packets believed that differentiation of academic work will allow students the opportunity to select specific skills and activities which will be of interest to them. Choosing three learning activities also allows students to find academically “good fit” work if any activity is too challenging to complete independently.

In addition, students may complete extra activities which could be used for bonus points if they choose. The additional activities also provide parents with optional learning activities to support their child’s learning.

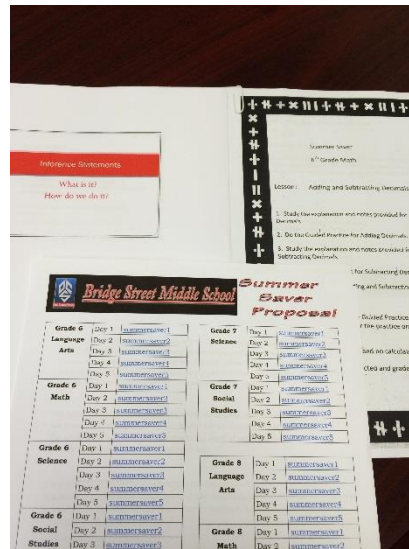

Middle School Exemplars

At the middle school programmatic level, Ohio County teachers who prepared the Exemplar Summer Saver packets focused upon “essential skills” that students need to build a strong foundation for more advanced skills.

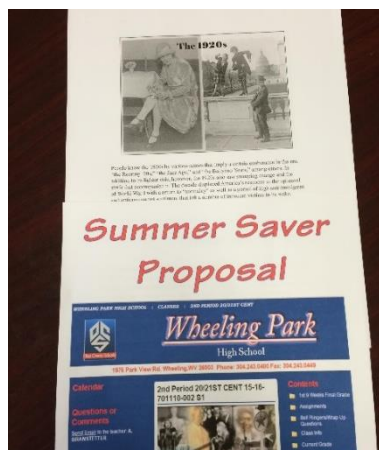

High School Exemplar

At the high school programmatic level, many teachers already utilize the “flipped” classroom concept by providing instructional materials on their Edline home pages. Students are able to access their materials electronically via a computer or their phones. Included as the high school exemplar is a sample lesson from a “flipped” social studies classroom already in existence.

Process to Monitor Participation, Outcomes, and Assessment of Student Learning for Reimagined Student Attendance/Instructional Days

Teachers will prepare lesson plans for Day 10 – Summer Saver 1, Day 11 – Summer Saver 2, Day 12 – Summer Saver 3, Day 13 – Summer Saver 4, and Day 14 – Summer Saver 5. The lesson plans will include all instructional materials for the “Summer Savers.” Lessons are monitored by the principals.

Principals will monitor student “Summer Savers” grades on Edline.

Teachers will provide instructions with each “Summer Saver” packet. They will provide their email addresses and will monitor via email during “Summer Savers” completion. Teachers will monitor and grade submission of the “Summer Savers” student work. Teachers will enter “Summer Savers” grades into Edline.

Parents will verify that students have completed their “Summer Savers” work by signing the included “Summer Savers” Checklist. Parents will monitor grades on Edline.

All students have Office 365 email accounts. Students will complete the “Summer Savers” Checklist to submit with their work.

Child Nutrition Considerations

Ohio County Schools Child Nutrition Program will prepare lunch meals to be served at the following locations: Madison Elementary School, Ritchie Elementary School, Bridge Street Middle School, and Warwood School on the five “Summer Saver” days. The Reimagined Time days will function similar to the summer meals program, and students will be able to eat lunch if they are able to come to these schools. All four identified schools are Community Eligibility Program schools.

Principals and aides will be able to supervise students participating in the lunch program.

Projected Impact on Budget

Ohio County Schools may save funds in the following areas if teachers and students are able to work at home for five instructional days.

- Reduction in fuel costs
- Reduction of school bus repairs
- Reduction of school facilities repairs
- Reduction in water costs
- Reduction in electric costs
- Reduction in the purchase of paper products (cafeterias, restrooms, lab classrooms)
- Possible savings in salaries for overtime work by maintenance snow plow crew
