Endnotes

County Waiver: Per West Virginia Code §18-5A-3, a request from a county board of education submitted to the West Virginia Board of Education (WVBE) to be exempted from a rule or rules promulgated by the WVBE. A county may seek a waiver for all elementary schools, all middle schools, all high schools or all schools in the county.

School (LSIC) Waiver: Per West Virginia Code §18-5A-3, a request from a Local School Improvement Council (LSIC) submitted to the WVBE to be exempted from a rule or rules promulgated by the WVBE. Two-thirds of the LSIC members must vote in favor of the waiver request and approval of the waiver request only applies to the individual school submitting the request.

Advanced Placement® School Waiver: A request submitted by a school or group of schools to the WVBE to be exempted from specific rules relating to Advanced Placement requirements in WVBE Policy 2510. The AP Waiver Request Form must be signed by the school principal and county superintendent.

Institution of Higher Educations: A request submitted by an institution of higher education to the WVBE to be exempted from specific rules relating to educator preparation program requirements in WVBE Policy 5100. The waiver request must include the name and signature of the dean of the College of Education and Teacher Preparation representative of the institution.
